

APPENDIX: CRS-FATCA SELF-CERTIFICATION - Main account holder

According to Parts XVIII and XIX of the *Income Tax Act*, Canadian financial institutions must collect the information required in this form to determine if they must provide information about your financial account to the Canada Revenue Agency (CRA). The CRA can provide this information to the government of a foreign jurisdiction in which you are a resident for tax purposes, or to the U.S. government if you are a citizen of that country. If such is the case, you can ask your financial institution about the nature of the information provided. In the case of a joint account, each holder must fill out a separate CRS-FATCA self-certification form.
