Management Discussion of Fund Performance

Results of Operations

For the six-month period ended June 30, 2025, the Meritage Conservative Income Portfolio's Advisor Series units returned 2.52% compared to 3.72% for the Portfolio's blended benchmark. The broadbased indices, the Morningstar® Canada Liquid Bond Index (CAD) and the Morningstar® Developed Markets Large-Mid Cap Index (CAD), returned 1.69% and 4.35% respectively. Unlike the indices, the Portfolio's performance is calculated after fees and expenses. Please see the *Past Performance* section for the returns of all of the Portfolio's series, which may vary mainly because of fees and expenses.

The Portfolio's net asset value dropped by 5.30% over the period, from \$87.92 million as at December 31, 2024 to \$83.26 million as at June 30, 2025.

The first half of 2025 was characterized by elevated volatility in the equity markets, including a sharp decline in April following the announcement of reciprocal tariffs by the U.S. administration, after which there was a strong rebound in May and June. As a result, equity markets ended the first half of the year with positive returns, with the S&P 500 significantly underperforming the rest of the world. Meanwhile, despite increased uncertainty, the Canadian fixed income universe has seen only marginal gains over the past six months, as investors wondered what the future holds for interest rates.

Specifically, overseas equities stood out with year-to-date total returns of +19.9% for the EAFE region and +15.6% for Emerging Markets. The S&P/TSX rose 10.2%, while the S&P 500 trailed with gains of 6.2%.

Within fixed income, concerns about the inflationary impact of tariffs, disappointment with the Trump administration's tax plan and the resilience of the U.S. economy all contributed to a less favorable environment for bonds. Ultimately, the Canadian fixed income universe ended the first half of the year with gains of 1.3%.

In commodities, oil was volatile amid geopolitical tensions in the Middle East but still ended the period down 8.5% (WTI), while gold continued its sustained climb with gains of 24.4%.

Finally, in currencies, the U.S. dollar had its worst start to the year in more than 50 years (-10.7% for the DXY), as the Greenback was shaken by the reassessment of American exceptionalism and the repatriation of foreign capital. The Canadian dollar appreciated more modestly against the U.S. dollar (+5.7% for the CADUSD).

Given this context, the Meritage Conservative Income Portfolio underperformed its blended benchmark over the period. The Beutel Goodman Canadian Dividend Fund, the BMO Dividend Fund, and the RBC Canadian Dividend Fund brought the most value to the Portfolio during the period. The Sun Life MFS Growth Fund, and the AGF American Growth Fund contributed the least value to the Portfolio's overall return over the period.

Recent Developments

On January 28, 2025, changes were made to the Portfolio in order to optimize it. Given this context, the CI Canadian Bond Fund, the TD Canadian Core Plus Bond Fund, the RBC Canadian Dividend Fund, and the Capital Group Global Equity Fund were reduced. These Funds were replaced by the increase in the RP Strategic Income Plus Fund, and the Manulife Strategic Income Fund, and the addition of the Beutel Goodman Canadian Dividend Fund, the GF American Growth Fund, the PH&N Overseas Equity Fund, the Sun Life MFS Global Growth Fund, the TD Global Equity Focused Fund, and the RBC Emerging Markets Equity Fund.

Equity markets got off to a turbulent first half of the year, with the reciprocal tariffs announced by the White House on April 2 being on such a scale as to jeopardize the global economy. However, it wasn't long before the Trump administration changed course and adopted a more conciliatory tone, leading to a strong stock market rebound that eclipsed the initial downturn.

In addition to the president's reversal on tariffs, renewed market optimism stems from the continued resilience of the U.S. economy; the labour market is still on track, corporate earnings remain relatively strong, and inflation shows no signs of re-accelerating so far. Furthermore, although there is still some underlying anxiety among consumers and businesses, confidence surveys have quietly begun to improve as the parameters of the White House's policy agenda become clearer.

On January 28, 2025, the blended benchmark was modified to better reflect the categories of assets in which the Fund invests. The current blended benchmark is composed of the Morningstar® Canada Liquid Bond Index (CAD) (70%), the Morningstar® Canada Large-Mid Index (CAD) (21%) and the Morningstar® Developed Markets Large-Mid Cap Index (CAD) (9%). The previous blended benchmark was composed of the Morningstar® Canada Liquid Bond Index (CAD) (80%) and the Morningstar® Canada Large-Mid Index (CAD) (20%). The current broadbased indices are the Morningstar® Canada Liquid Bond Index (CAD) and the Morningstar® Developed Markets Large-Mid Cap Index (CAD). The previous broad-based index was the Morningstar® Canada Liquid Bond Index (CAD).

On or about May 14, 2025, National Bank Investments Inc. ("NBI") replaced National Bank Trust Inc. ("NBT") as portfolio manager of the Fund. The investment objectives of the Fund remain unchanged. This change has no impact on the sub-advisor currently making investment decisions for the Fund.

Related Party Transactions

National Bank of Canada ("the Bank") and its affiliated companies' roles and responsibilities related to the Portfolio are as follows:

Trustee, Custodian and Registrar

Natcan Trust Company ("NTC"), an indirect wholly-owned subsidiary of the Bank, is the Portfolio's trustee. In this capacity, it is the legal owner of the Portfolio's investments.

NTC also acts as the Portfolio's custodian, registrar and transfer agent. The Manager pays NTC for its services as custodian based on the assets held by the Portfolio. In addition, a flat fee per transaction is paid to NTC. With respect to the registrar and transfer agent services for the Portfolio, a fixed annual amount is paid to NTC by the Manager.

Agent for securities lending transactions

NTC acts as the agent for securities lending transactions acts on behalf of the Portfolio in administering securities lending transactions entered into by the Portfolio. NTC is an affiliate of the Manager.

Manager

As described in the Management Fees section, the Portfolio pays annual management fees to National Bank Investments Inc. (the "Manager") in consideration for management services. The management fees cover mainly the Manager's costs of managing the Portfolio's investments. The Manager is an indirect wholly-owned subsidiary of National Bank of Canada (the "Bank").

Since October 29, 2013, the Manager pays the operating expenses of the Portfolio other than its "portfolio costs" (defined below) (the "variable operating expenses"), in exchange for the Portfolio's payment to the Manager of annual fixed-rate administration fees with respect to each series of the Portfolio.

The administration fees are equal to a specified percentage of the net asset value of each series of the Portfolio, calculated and paid in the same manner as the Portfolio's management fees. The variable operating expenses payable by the Manager include, but are not limited to: transfer agency and recordkeeping costs; custodial costs; accounting and valuation fees; audit fees and legal fees; costs of preparing and distributing financial reports, simplified prospectuses, annual information forms, fund facts, continuous disclosure material and other securityholder communications; and costs of trustee services relating to registered tax plans, as applicable.

In addition to administration fees, the Portfolio shall also pay certain portfolio costs, namely: taxes (including, but not limited to, GST/HST and income taxes); costs of compliance with any changes to existing governmental or regulatory requirements introduced after August 1, 2013; costs of compliance with any new governmental or regulatory requirements, including any new fees introduced after August 1, 2013; interest and borrowing costs; costs related to external services that were not commonly charged in the Canadian mutual fund industry as at August 1, 2013; Independent Review Committee costs, including compensation paid to IRC members, travel expenses, insurance premiums and costs associated with their continuing education; and variable operating expenses incurred outside of the normal course of business of the Meritage Portfolios.

The Manager may, from time to time and at its sole discretion, decide to absorb a portion of a series' management fees, administration fees or Portfolio costs.

Portfolio Manager

The Manager has appointed National Bank Investments Inc. ("NBI"), an indirect wholly-owned subsidiary of the Bank, as the portfolio manager for the Portfolio. NBI acts as both Manager and portfolio manager of the Portfolio.

Distribution and Dealer Compensation

Portfolio securities are offered by National Bank Direct Brokerage (a division of National Bank Financial Inc., an indirect wholly owned subsidiary of the Bank), National Bank Financial Inc. and other affiliated entities. Each month, brokers receive a commission representing a percentage of the average daily value of the securities held by their clients. In addition, when Advisor Series securities are purchased, brokers usually receive a commission, which varies depending on the sales charge option chosen at the time of investment.

Brokerage Fees

The Portfolio may pay broker's commissions at market rates to a corporation affiliated with National Bank Investments Inc. The brokerage fees paid by the Portfolio for the period are as follows:

Holdings

As at June 30, 2025, National Bank Investments Inc. held 178.02 Portfolio securities for a value of \$1,707.22, which represented close to than 0.0015% of the net asset value of the Portfolio at that date. Transactions between National Bank Investments Inc. and the Portfolio were carried out in the normal course of business and at the Portfolio's net asset value as at the transaction date.

Administrative and Operating Services

NBT provides the Portfolio with certain services, including accounting, reporting and portfolio valuation services. The costs incurred for these services are paid by the Manager to NBT.

Management Fees

The Portfolio pays annual management fees to the Manager in consideration for management, portfolio advisory and administrative services and facilities required by the Portfolio in its day-to-day operations. As the Portfolio invests in underlying funds, the fees and expenses payable in connection with the management of the underlying funds are in addition to those payable by the Portfolio. However, the Manager makes sure that the Portfolio does not pay any management (or operating) fees that, to a reasonable person, would duplicate a fee payable by the underlying fund for the same service.

The management fees are calculated as a fixed percentage of the Portfolio's daily net asset value, are accrued on a daily basis and are paid monthly. The Portfolio is required to pay applicable taxes on the management fees.

Under the heading *Distribution*, expenses include the broker's compensation consisting of the maximum annual trailer fees and sales commissions paid to brokers. Under the heading *Other*, the fees relate mainly to investment management, investment advisory services, general administration and profit. The breakdown of the main services received in consideration for the management fees, as a percentage of the management fees collected from the Portfolio, is as follows:

NBI does not pay any commissions or service fees to dealers who sell O Series units. There are no sales charges payable by investors who purchase O Series units.


Past Performance



The management expense ratio includes, if necessary, the management expenses from its underlying funds, as described in Article 15.2 of Regulation 81-106.

The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the accounting period. The trading expense ratio includes, if necessary, the trading expenses from its underlying funds, as described in Article 15.2 of Regulation 81-106.

The portfolio's turnover rate indicates how actively the Portfolio's manager manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Portfolio buying and selling all of the securities in its portfolio once in the course of the accounting period. The higher a portfolio's turnover rate in an accounting period, the greater the trading costs payable by the Portfolio in the accounting period, and the greater the chance of an investor receiving taxable capital gains in the accounting period. There is not necessarily a relationship between a high turnover rate and the performance of a Portfolio.
