Management Discussion of Fund Performance

Investment Objective and Strategies

The NBI Precious Metals Fund aims to achieve long-term growth through investment primarily in securities of companies or securities whose value is dependent upon the value of gold, silver, platinum and palladium ("Precious Metals") or strategic metals (such as rhodium, titanium, chromium, cobalt and iridium) or strategic minerals or diamonds.

The portfolio manager analyzes Canadian and foreign companies engaged in the exploration for, or the mining, production or distribution of Precious Metals. The portfolio manager may also invest directly in Precious Metals by buying bullion, coins or certificates and other evidences of purchase. It is expected that investments in foreign securities will not exceed approximately 30% of the Fund's net assets.

Risks

The global investment risk of the Fund remains as described in the simplified prospectus or any amendments thereto and Fund Facts.

Results of Operations

For the twelve-month period ended December 31, 2024, the NBI Precious Metals Fund's Investor Series units returned 20.55% compared to 22.32% for the Fund's blended benchmark. The broadbased index, the S&P/TSX Gold Index (CAD), returned 18.38%. Unlike the indices, the Fund's performance is calculated after fees and expenses. Please see the *Past Performance* section for the returns of all of the Fund's series, which may vary mainly because of fees and expenses.

The Fund's net asset value rose by 11.01% over the period, from \$22.42 million as at December 31, 2023 to \$24.89 million as at December 31, 2024.

The increase stemmed mainly from market fluctuations.

The price of gold appreciated 27% in 2024 while silver rose 21%, relatively in line with the respective returns of the S&P/TSX sub-indices. In October, the price of gold surged to a new record high of USD 2,740 per ounce amid ongoing geopolitical and economic uncertainty, and closed the year at USD 2,624 per ounce.

In this context, the Fund underperformed its benchmark.

Positive attribution came from the Fund's positions in Osisko Gold Royalties (+17%), Orla Mining (+84%), and Wesdome Gold Mines (+67%). However, security selection within the Gold sub-index ultimately detracted from relative performance as a position in Barrick Gold (-5%) lagged amid weaker-than-expected 2025 production guidance and ongoing disputes with the Government of Mali over taxation and ownership. The Portfolio Manager believes shares are discounted to reflect the worst-case outcome and continues to see significant value in the company. The Fund's overweight position in diversified metals and mining also acted as a detractor from relative performance.

Over the last 12 months, the Fund invested as much as 20.10% of its net assets in securities of Barrick Gold Corp, 19.30% of its net assets in securities of Franco-Nevada Corp and 17.00% of its net assets in securities of Wheaton Precious Metals Corp.

Recent Developments

The Portfolio Manager's strategy for the NBI Precious Metals Fund remains focused on owning higher quality (profitable) firms that have greater operational expertise and financial resources (i.e., more cash than debt). Given the uncertainty in global markets, the investment team believes it is prudent to own a portfolio of both producers and royalty companies.

Consistent with this strategy, during the year the Portfolio Manager initiated three new positions:

Triple Flag Precious Metals, a mid-tier precious metals royalty company, valued at a discount to its larger royalty peers, making it an attractive and accretive acquisition target. Activist manager Elliott Investment Management now owns over 66% of the company's shares and may be advocating for a sale.

Hecla Mining Company, a mid-sized silver and gold producer with world-class properties that offer significant mine life extension potential, making them attractive targets for senior producers looking to replace reserves.

Osisko Gold Royalties, a mid-sized royalty company with a diverse portfolio of some of the highest-quality precious metal royalties and streams located primarily in North America and Australia.

The Portfolio Manager exited a position early in the year, SSR Mining, as the investment thesis changed following the heap leach failure at its Turkish Mine.

The portfolio remains overweight the Diversified Metals and Mining sub-Index and underweight the Silver sub-Index.

Despite significantly higher bullion prices, the Portfolio Manager continues to view near-term risks for gold producers as elevated given that unit operating and capital costs remain well above pre-pandemic levels. As such, cash margins could quickly compress should demand falter at a time when the costs associated with replacing existing production are unprecedented.

The investment team continues to focus on investing in either precious metal companies with established production and lower-cost operations or diversified royalty/streaming companies that typically have lower operational risk.

Related Party Transactions

National Bank of Canada ("the Bank") and its affiliated companies' roles and responsibilities related to the Fund are as follows:

Trustee, Custodian, and Registrar

Natcan Trust Company ("NTC"), an indirect wholly-owned subsidiary of the Bank, is the Fund's trustee. In this capacity, it is the legal owner of the Fund's investments.

NTC acts as registrar for the Fund's securities and the names of securityholders. NTC also acts as the Fund's custodian. The fees for NTC's custodial services are based on the standard rates in effect at NTC

Agent for securities lending transactions

NTC acts as the agent for securities lending transactions acts on behalf of the Fund in administering securities lending transactions entered into by the Fund. NTC is an affiliate of the Manager.

Fund Manager

The Fund is managed by National Bank Investments Inc. ("NBI"), which is an indirect wholly-owned subsidiary of the Bank. Therefore, NBI provides or ensures the provision of all general management and administrative services required by the Fund's current operations, including investment consulting, the arrangement of brokerage contracts for the purchase and sale of the investment portfolio, bookkeeping and other administrative services required by the Fund.

The Manager pays the operating expenses of the Fund other than its "Fund costs" (defined below) (the "variable operating expenses"), in exchange for the Fund's payment to the Manager of annual fixed-rate administration fees with respect to each series of the Fund.

The administration fees are equal to a specified percentage of the net asset value of each series of the Fund, calculated and paid in the same manner as the Fund's management fees. The variable operating expenses payable by the Manager include, but are not limited to: transfer agency and recordkeeping costs; custodial costs; accounting and valuation fees; audit fees and legal fees; costs of preparing and distributing financial reports, simplified prospectuses, annual information forms, Fund Facts, continuous disclosure material and other securityholder communications; and costs of trustee services relating to registered tax plans, as applicable.

In addition to administration fees, the Fund shall also pay certain Fund costs, namely: taxes (including, but not limited to, GST/HST and income taxes); costs of compliance with any changes to existing governmental or regulatory requirements introduced after August 1, 2013; costs of compliance with any new governmental or regulatory requirements, including any new fees introduced after August 1, 2013; interest and borrowing costs; costs related to external services that were not commonly charged in the Canadian mutual fund industry as at August 1, 2013; Independent Review Committee costs, including compensation paid to IRC members, travel expenses, insurance premiums and costs associated with their continuing education; and variable operating expenses incurred outside of the normal course of business of the Fund.

The Manager may, from time to time and at its sole discretion, decide to absorb a portion of a series' management fees, administration fees or Fund costs.

As described under the heading *Management Fees*, the Fund pays annual management fees to NBI as consideration for its services.

Portfolio Manager

The Manager has appointed National Bank Trust Inc. ("NBT"), a direct and indirect wholly-owned subsidiary of the Bank, as the portfolio manager for the Fund. A flat fee is payable annually to NBT for its management services.

Distribution and Dealer Compensation

National Bank Savings and Investments Inc. ("NBSI") acts as principal distributor for the Fund. In this capacity, NBSI buys, sells and swaps securities through Bank branches and the National Bank Investments Advisory Service in Canadian provinces and territories, and through external registered representatives. Fund securities are also offered by National Bank Financial Inc. (including its division National Bank Direct Brokerage) and other affiliated entities. Brokers may receive, depending on the distributed series, a monthly commission representing a percentage of the average daily value of the securities held by their clients.

Brokerage Fees

The Fund may pay broker's commissions at market rates to a corporation affiliated with NBI. The brokerage fees paid by the Fund for the period are as follows:

Independent Review Committee Approvals and Recommendations

The Fund followed the standing instructions of its Independent Review Committee with respect to one or more of the following transactions:

- a) Purchasing or holding the securities of a related issuer, in particular, those of National Bank of Canada;
- Investing in the securities of an issuer when an entity related to the manager acts as an underwriter for the placement or at any time during the 6o-day period after the end of the placement;
- Purchasing or selling securities to another investment Fund managed by the manager or a company in the same group;
- d) Purchasing or selling debt securities on the secondary market, through related brokers that are main brokers in the Canadian debt securities market (in accordance with an exemption received from the Canadian Securities Administrators):
- Entering into foreign exchange transactions (including both spot transactions and forward transactions) with National Bank of Canada.

The Manager has implemented policies and procedures to make sure that the conditions applicable to each of the above transactions are met. The applicable standing instructions require that these transactions be carried out in accordance with NBI policies, which specify, in particular, that investment decisions pertaining to these related party transactions must be made free from any influence by an entity related to NBI and without taking into account any consideration relevant to an entity related to NBI. Furthermore, the investment decisions must represent the business judgment of the securities advisor, uninfluenced by considerations other than the best interest of the Fund and must achieve a fair and reasonable result for the Fund.

Registered Plan Trust Services

NTC receives a fixed amount per registered account for services provided as trustee for registered plans.

Administrative and Operating Services

The provision of certain services was delegated by the Fund Manager, NBI, to National Bank Trust Inc. ("NBT"), a direct and indirect whollyowned subsidiary of the Bank. These include accounting, reporting and portfolio valuation services. The fees incurred for these services are paid to NBT by the Fund manager.

Management Fees

The Fund pays annual management fees to the Fund manager for its management services. The fees are calculated based on a percentage of the Fund's daily net asset value before applicable taxes and are paid on a monthly basis. Under the *Distribution* heading, expenses include the broker's compensation consisting of the maximum annual trailer fees and sales commissions paid to brokers. Under the *Other* heading, the fees relate mainly to investment management, investment advisory services, general administration and profit. The breakdown of major services provided in consideration of the management fees, expressed as an approximate percentage of the management fees is as follows:

Past Performance


